Communication Board memos will be posted in the shared drive, Field Lifeguard Folder. It is important that each lifeguard reads the board in order to stay up to date. Please do not add any materials that are not authorized by an Aquatic Supervisor.

The Communication Board procedure is:

1. When a new memo(s) is generated a notifying email will be sent to the Head Lifeguard.
2. The LG III or his/her designee will place the new memo on a computer desktop folder to save paper and printer wear or will print and post on the station clipboard. The memo should be placed in front of older memos (memos are ordered numerically at the bottom of the page)
3. At least once a week, each lifeguard must read any new memos and initial on the Communication Board Record (this page should be kept on the front of the clipboard) indicating the memos they have read. The LG III will be responsible for ensuring compliance.

Now that you understand this method, please initial on the Communication Board Record that you have read Memo # 2010-1. Thank you for your cooperation in helping us ensure information is disseminated efficiently.

Re: Early Season Assignments

The following are special assignments that will need your attention as we begin service:

1. Pay special attention while performing equipment checks.
2. Complete Underwater Hazard Inspections, opening day of lifeguard service at your facility.
3. Complete inventory assignment by the end of the second day of lifeguard service at your facility.
4. Make sure lifeguard equipment, station, and facility are clean and organized.
5. Collect minor consent forms and work permits (due first day of work) from any minors on your staff and forward to your Aquatic Supervisor.
6. Administer the check-in process for returning lifeguards that did not attend the Returning Lifeguard Check-in Meeting. Refer to the PIC Check-in Instructions, located in the Employee Form Box.
7. Lead quality training sessions according to Lifeguard Training Calendar.
8. Update lifeguard station postings with those provided.
9. Complete scheduling as needed to meet facility needs. Immediately notify your Aquatic Supervisor of all scheduling changes via telephone/voice-mail.
10. Maintain good communication with Aquatic Supervisor to ensure that needs are met at your facility.

These assignments will contribute to attaining our Lifeguard Service mission and are especially important during this time of year. If you have any questions do not hesitate to contact your Aquatic Supervisor.

Re: Returning Lifeguard Procedures

It is critical that the returning lifeguard hiring procedures are followed closely. Every returning lifeguard who wishes to work this season needs to correctly complete this hiring process. This process is detailed in the District's flyers inviting applications for Lifeguard I (Returning), Lifeguard II and Lifeguard III.

Candidates for lifeguard positions are placed in a hiring pool following a selection process that evaluates items such as, application materials, certificate status, past work performance, availability and District needs. There are returning lifeguard candidates who are not eligible for employment based upon this selection process.

It is critical that no lifeguard initiates the check in process without first contacting an Aquatic Supervisor to insure they are in a hiring pool.

Any questions should be addressed to an Aquatic Supervisor.

Extensive revisions were made to the Lifeguard Service Manual over the winter. Please take the time to reacquaint yourself with the contents.

Re: Policy on Harassment

The following is a reminder about the District's policy on harassment from the Human Resources Manager.

Re: Lifeguard Certifications

The District conducts Red Cross certification courses necessary to maintain minimum lifeguard certifications at scheduled times throughout the season. These dates are posted in the Lifeguard Station on the 2010 Lifeguard Service Important Dates Schedule.

This memo's attachment provides certification expiration dates from Human Resources. **Please do not print the attachment as it is very long.** You can look up individuals by using the "search" tool and typing in a guard's name to "find" it. Please take the time to check the list and take note of your certificate's expiration date, this will help in determining which re-certification classes you will need to attend. Courses are a challenge format. Certifications in Waterfront Lifeguarding and CPR for the Professional Rescuer/AED are awarded to successful staff during the Waterfront Lifeguarding Challenge.

Keep in mind that it is mandatory that all lifeguards attend one of the Lifeguard Challenge re-certification classes in order to attempt the required 550-yard swim in the open water and in order to keep your CPR for the Professional Rescuer/AED certificate valid.

Because of the potential size of these trainings, you may be limited to attending certain Lifeguard Challenge re-certification classes. All those holding current Emergency Response certificates expiring prior to August, 2010 should enroll in the Emergency Response challenge. All Title 22 certificates should be valid through this date. If not contact your Aquatic Supervisor.

Contact your Lifeguard III to be scheduled for the appropriate course.

Job required certifications on the new lifeguards are being processed with the Red Cross and are not on the attached list. Each new lifeguard is current in Lifeguarding, Title 22 first aid and CPR FPR/AED unless they have any outstanding test to complete. If that's the case, they should not be released from shadow guarding.

If you feel that the data file is inaccurate, or needs to be updated, please provide a copy of your certificate(s) to the Human Resources Department as soon as possible. It is ultimately your responsibility as a lifeguard to keep your job-required certificates valid and up-to-date.

Lifeguards who don't possess valid job required certification will be taken off the schedule immediately until they meet the minimum requirement(s).

Re: Miscellaneous Reminders

1. **Medications:** LSM A-2.1 Per the Personnel Administrative Manual, Appendix C, Ethical Guidelines Policy: Any employee who is taking medication which may impair his/her ability to work safely and efficiently must inform his/her supervisor.
 - a. Application by supervisor: Prescription – needs Dr. explicit written OK to lifeguard while taking. Over-the-counter – no drowsiness or physical impairment on warning label (or Dr. explicit written OK).
2. **Sunglasses:** Are recommended for personal protection as well as a useful tool. The USLA manual has good information regarding the importance and selection of sunglasses on page 305 and 306. Please read this section. Some key points: good sunglasses aren't necessarily expensive. UVA, UVB, good wrap around fit, and polarization are important. Polarization in the water environment is especially useful. It decreases glare and thus increases the ability to see.
3. **Public Education Portable Signs:** LSM S-3.6 lists approved messages for these boards. Here are a couple more. "Water quickly hides and suffocates. Please swim safely" "Don't multitask at the beach/pool. Watch your children"
4. **Expense Reports:** Use 000 as the location code for all expenses except mileage reimbursement. For mileage reimbursement, use the location code of the park that you are traveling to. See LSM A-1.5 for more information.
5. **Drug and Alcohol Policy:** LSM A-3.5 contains excerpts of the District's Drug and Alcohol policy for non-safety sensitive employees regarding lifeguard reasonable suspicion testing. The entire Human Resources Policy #15 can be found at S:\FIRE OPERATIONS\Aquatics\Field Lifeguard Folder\Form Box template 09 if someone would like more information.

Re: Title 22 Skills

Starting in 2008, upon completion of the lifeguard academy, lifeguard cadets received a certification in Title 22: First Aid for Public Safety Personnel. While this course is very similar to Emergency Response, there are some differences in the skills that lifeguard certified in Title 22 are able to perform. The following list can be used by lifeguards to verify whether or not skills are included in the Title 22 scope of practice.

- Emergency Moves
 - Urgent Moves
 - Fire Fighter Carry, Clothes Drag, Blanket Drag, Shoulder Drag and Pack Strap Carry.
 - Non-Urgent Moves
 - Direct lift, Extremity lift, Direct Carry, Draw sheet
- Initial Assessment
- Physical Exam
- SAMPLE History
- Controlling external Bleeding
- Bandaging embedded object
- Splinting bones, joints and extremity
- Head Injury
- Spinal Management
 - Inline stabilization, Cervical Collar, Backboard, Spider Straps and CMSTP
- Assist with glucose

The following skills are **NOT** included in the Title 22 scope of practice. This means lifeguards certified in Title 22 cannot perform these skills.

- Blood Pressure
- OPA
- NPA
- Suction

Re: Med Pack Off Beach

There has recently been some discussion as to whether taking the Med Pack off the beach requires the water to be cleared until the Med Pack is available again.

To answer the question with one sentence: **Taking the Med Pack off the beach does not automatically mean the water needs to be cleared.**

The procedure to follow can be found in our LSM section E-4.2 Medical Outside Facility.

A brief explanation may be helpful. We are relying on good judgment in making the appropriate decision as part of E-4.2's procedure.

First, the PIC should evaluate whether it's appropriate to have anyone leave the beach in the first place? Remember, our primary purpose is to do the best we can in providing for the safety of the public in our swim areas. This is mostly provided through water coverage by personnel not equipment. If the situation appears to require potentially lifesaving measures to a park visitor outside of the swimming area, and there are not other comparable resources available in a timely way, it is almost surely a good idea to help. It may be best to send one guard to investigate first. If the above scenario requires us to compromise our water coverage by personnel, we should clear the water. There are a myriad of factors that may affect this decision, thus the need for good staff judgment.

Having no Med Pack at the beach and swimmers in the water begs the question – what happens if we need the Med Pack at the beach while it's gone on the other medical? This is likely to be an extremely rare occurrence. If it does happen, try to free up the Med Pack and personnel as soon as possible by transferring care, but in the meantime, provide the best care you can with the resources available.

Re: Additional Cash Sale Uniform Items

.Re: Guarding Strategies

We've modified some of our guarding strategies this season. Our LSM will reflect these guidelines in its next revision, in the meantime, please review and implement the following.

Gate Keeper

We are calling one of our alternate stations a "gate keeper." This position's primary objective is to keep people from drowning (as is all guard's) but secondarily they are to keep people who can't swim well from going past chest deep water. Typically the guard will position themselves past the wading rope in approximately chest deep water, facing toward shore. The majority of their time should be spent scanning their zone and preventing weak swimmers from going past chest deep water. The guard should be wearing the rescue floatation device's strap as indicated in LSM S-1.6. They should walk within their zone (usually one or two chair zones) when necessary to complete their objectives. They may also need to address child supervision infractions and other preventive duties.

We are using a modified gate keeper station at Contra Loma as a pilot program so that we can assess its effectiveness. The responsibility of this position is similar to the above but the guard is prohibiting everyone who is not wearing a PFD or a swim test wrist band from going past the wading rope.

As a crowd management strategy (LSM E-1.3) having the gate keeping restrict access to deep water, as is done regularly in CL's pilot program, may be appropriate.

Child Supervision

For a number of years we've been working to improve our child supervision rule compliance. With this in mind, those assigned to the alternate station of child supervision should be where the unattended children are most likely to become endangered (or removing a child from danger by taking them to their guardian). This means most of the time they should also be in the water identifying which guardians are supervising which children.

As a reminder from LSM S-3.5:

- In an effort to provide guidance to lifeguards in determining whether a guardian is "actively supervising" their children; those 7 years old and younger should generally be approximately arms reach away.
- Children that are 8-13 years old should have their guardian facing the water, with their children in sight and within vocal distance. The guardian should be readily identifiable to the lifeguard while talking to the child.
